

RESOLUTION NO. 18 - 669

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MENIFEE, CALIFORNIA, DESIGNATING THE TIME, DATE AND LOCATION OF PARKS, RECREATION AND TRAILS COMMISSION MEETINGS AND DESIGNATING LOCATIONS FOR POSTING AGENDA

WHEREAS, on April 16, 2014, the City Council of the City of Menifee adopted Ordinance No. 2014-143 adding Chapter 2.30 to the Menifee Municipal Code providing for a Parks, Recreation and Trails Commission; and

WHEREAS, the City Council has amended Ordinance No. 2014-143 to update time, date, and/or location of meetings with Ordinance Nos. 2015-163, 2015-169, and 2015-172; and

WHEREAS, on June 7, 2017, the City Council unanimously (5-0) authorized to no longer be dark in the month of July and authorize staff to update the regular meeting schedules for City Council, City Commissions and City Committees as necessary; and

WHEREAS, currently the Parks, Recreation and Trails Commission meet twice per month, while often the second meeting is cancelled due to lack of agenda items, therefore staff recommends holding one regular meeting per month; and

WHEREAS, in an effort to streamline the process and for improved efficiency, the time, date and location of regular meetings of the Parks, Recreation and Trails Commission will be taken out of Chapter 2.30, section 080 of the Menifee Municipal Code and established in a resolution.


NOW, THEREFORE, the City Council of the City of Menifee does resolve and orders as follows:

SECTION 1. TIME, DATE AND LOCATION OF REGULAR CITY COUNCIL MEETINGS. The regular meetings of the Parks, Recreation and Trails Commission shall be held at 6:00 p.m. on the first Thursday of each month (unless the same shall be a legal holiday, in which case the regular meeting shall be held on the next succeeding day or on another day as determined by the Commission and posted), unless the Parks, Recreation and Trails Commission decides to cancel a meeting, at which time the Clerk would post the required cancellation notice.

SECTION 2. POSTING PLACES. All agendas and resolutions required by law to be published or posted shall be posted in at City Hall and in at least three (3) public places within the City of Menifee in accordance with the provisions of Government Code Section 36933, which locations are as follows:


