RESOLUTION NO. 16-511

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MENIFEE, CALIFORNIA, MODIFYING AND ESTABLISHING RECREATION AND PARK USE FEES AND CHARGES FOR SERVICES PROVIDED BY THE CITY OF MENIFEE

Whereas, the City of Menifee provides miscellaneous public services of a discretionary nature as these services can be withheld from customers for non-payment, in addition to community-supported public services which are paid for by City tax revenues for general social, safety or welfare reasons; and

Whereas, in 2008 the City of Menifee adopted the Recreation and Parks use fee schedule of the County of Riverside and desired to adjust and establish certain fees and charges based on reasonable costs borne by the City for providing said services; and

Whereas, on August 20, 2014 the Menifee City Council adopted Resolution No. 14-391 establishing a fee schedule for recreation programs, services, and park facility use in the City of Menifee; and

Whereas, the Menifee City Council desires to modify the fee schedule for recreation programs, services, and park facility use to more effectively recover costs for service; and

Whereas, the City of Menifee, Parks, Recreation and Trails Commission has reviewed and recommend City Council adopt the revised fees and rates for said services; and

Whereas, the City of Menifee held a duly noticed Public Hearing to provide public input and review concerning adjustments and establishment of rates for said services.

NOW, THEREFORE, the City Council of the City of Menifee, California, does hereby RESOLVE, DETERMINE and ORDER as follows:

<u>SECTION 1</u>: It is hereby found and determined that the fees and charges set forth in Exhibit A attached hereto do not exceed the estimated reasonable costs of providing services for which the fee is charged or the estimated amount required to provide the service for which the fee or charge is levied.

SECTION 2: The revised User Fee Schedule shall go into effect on May 5, 2016.

SECTION 3: In addition to the fees and charges in Exhibit A attached hereto, the City shall impose those fees and charges for services such as photocopying of designated records, response to subpoenas, and similar services, established by enacted State legislation, promulgated State regulation, and orders of determinations issued by State agencies, the County of Riverside, or other regional agencies having jurisdiction over the activities or functions to which such fees and charges relate. The City shall charge the amount or rate of such fees and charges that are in effect as of the date of the fee or charge is imposed or billed by the City.
